

I will show how sparse grids can be used to provide an efficient method for the estimation of high dimensional probability density functions (pdf's). We take a simple approach and obtain an estimate of a pdf using an  $L^2$  & Mixed Sobolov semi-norm projection method. This method has the potential to provide an efficient method for estimating pdf's in very high dimensions.
